COVID-19 UPDATES: GETTING BACK TO WORK IN THE NEW NORMAL

Please continue following the below workplace guidance, which remains in effect:

- All individuals are required to wear a face covering at all times onsite (except when in your personal workspace)
- All personnel should continue self-monitoring and reporting potential COVID-19 exposure and symptoms, as follows:
 - Subcontractors MUST immediately report symptoms and exposure to their onsite manager and Orion Consortium.
- Daily at-home health checks should continue to be performed:
 - Take your temperature before reporting to work. If it reads 100.4 degrees or higher, do not report to work, notify your management, and contact your healthcare provider for further guidance
 - Assess your risk of exposure. In the past 14 days, have you been in close contact with someone who was diagnosed with or experiencing symptoms of COVID-19? If the answer is yes, contact your manager for guidance prior to reporting to work.
- Continue to protect yourselves and those around you by following CDC guidelines for staying healthy, including frequent handwashing and practicing social distancing.

Volunteers will assist with sorting and packing food at the Maryland Food Bank's Baltimore location, the central hub for food distribution to Central Maryland. The Food Bank relies on its member organizations (<u>network partners</u>) to distribute food directly to those in need. With more than 1,250 distribution partners – ranging from pantries and shelters to senior centers and schools – the MFB is able to get food into the hands of hungry Marylanders statewide.

CWIP COMPLIANCE

CWIP is the Client's Cyberspace Workforce Improvement Program. Contracted support personnel assigned to perform cyberspace work roles must meet their established qualification standards.

Employees must obtain an A+, Network+, or Security+ (or higher level) certification.

The certification deadline for GES employees was 5/31/2020. Employees on other contracts should be aware that this government mandated compliance will eventually apply to all contracts and should begin preparing for certification.
